

## **Energy requirement in the utilisation phase**

Power requirement for component


•	Minimum power consumption	0.1 W
•	Average power consumption	1.5 W
•	Typical energy consumption per year	13.1 kWh

The energy requirement evaluation was performed for a typical utilisation scenario. The European electricity mix from ecoinvent 2.2 was used to evaluate the power consumption in the utilisation phase.

### Calculation of the environmental impact

Evaluation over the entire life stage of 10 years in a typical utilisation scenario. The results additionally shown are based on a method of ecological scarcity that combines various environmental effects into an "environmental impact points" key figure. The method is based on Switzerland's environmental targets and evaluates the individual effects depending on the "Distance to Target".
